

WOODS ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at intersection of South Broadway and New Troup Hwy; south on Broadway to Loop 323; east on Loop 323 to Copeland Road; south on Copeland Road to District line; east, north, and east along District line to New Troup Hwy; northwest and west on New Troup Hwy to Broadway, the place of beginning.

Special Area

Begin at the intersection of Hwy 155 and Ben Street; south on Hwy 155 to Loop 323; east on Loop 323 to the Railroad; north along Railroad to Ben Street; west on Ben Street to Hwy 155; the place of beginning.

BOULTER MIDDLE SCHOOL - ATTENDANCE AREA

Begin at the intersection of Highway 64 and an imaginary line 100' west of Trinity Drive; north along this imaginary line to a point just south of Highway 110; northwest on imaginary line just south of Hwy 110 to the District line on the north; follow the District line on the north to a line just west of Texas College Road; south along this line to Loop 323; northeast on Loop 323 to an imaginary line extension from Grand Avenue; south on this imaginary line and Grand to Vance; east on Vance to Palace; south on Palace to Harmony; west on Harmony to Grand; south on Grand to Cochran; west on Cochran to Moore; south on Moore to Pickney; east on Pickney to Grand; south on Grand to Selman; west on Selman to Moore; south on Moore to Oakwood; east on Oakwood to Grand; south on Grand to Claude; west on Claude to Ross; south on Ross to Erwin; west on Erwin and Hwy 64 to imaginary line 100' west of Trinity Drive, the place of beginning.

DOGAN MIDDLE SCHOOL - ATTENDANCE AREA

Begin at the intersection of the District line on the north and an imaginary line east of Texas College Road; south along this imaginary line to Loop 323; south from Loop 323 on an imaginary line extension from Grand Avenue and Grand Avenue to Vance; east on Vance to Palace; south on Palace to Harmony; west on Harmony to Grand; south on Grand to Cochran; west on Cochran to Moore; south on Moore to Pickney; east on Pickney to Grand; south on Grand to Gentry; east on Gentry to Berta; east on Berta and an imaginary line extension of Berta to District line; north on District line to a point between Story and Rogers; east along this imaginary line to Loop 323; north on Loop 323 to Morningside; east on Morningside to District line; follow District line north and west to place of beginning.

HUBBARD MIDDLE SCHOOL - ATTENDANCE AREA

Begin at the intersection of District line on the east and an imaginary line extension of Plume Drive; west on the imaginary line extension of Plume to Old Troup Hwy; northwest along Old Troup Hwy to New Troup Hwy; northwest on New Troup Hwy to Dulse; west on Dulse to Broadway; south on Broadway to Fair Lane; west on Fair Lane to Old Jacksonville Hwy; south on Old Jacksonville Hwy to its intersection with the Noonday-Gresham Road; west on Noonday-Gresham Road to the Old Palestine Road; south on Old Palestine Road to District line; follow the south District line east and north to the place of beginning.

Special Area No. 1

Begin at intersection of County Road 364 and Loop 323; from this point, follow an imaginary line northeast to Madison; east on Madison to Hwy 155; southwest on Hwy 155 to Loop 323; northwest on Loop 323 to its intersection with County Road 364, the place of beginning.

Special Area No. 2

All middle school students residing on the following described portions of Lake Placid Road, County Roads 1130, 1131, and 1141, or on any road that deadends off the described portions of these roads, are to attend Hubbard Middle School: Begin at the intersection of Lake Placid Road and Hwy 155; southwest on Lake Placid Road to its intersection with County Road 1131; north on County Road 1131 to its intersection with County Road 1130; east on County Road 1130 to its intersection with County Road 1141; south on County Road 1141 to its intersection with Lake Placid Road.

HOGG MIDDLE SCHOOL - ATTENDANCE AREA

Begin at the intersection of the St. Louis Southwestern Railroad and Berta; southwest along the St. Louis SW Railroad to Beckham; south on Beckham to the Missouri Pacific Railroad; northwest on the Railroad to Wylie; south on Wylie and Pollard to DuIse; west on DuIse to Broadway; south on Broadway to Fair Lane; west on Fair Lane to Old Jacksonville Hwy; south on Old Jacksonville Hwy to its intersection with Noonday-Gresham Road; west on Noonday-Gresham Road to Old Palestine Hwy; south on the Old Palestine Hwy to the District line; follow the District line west to its intersection with Hwy 155; north on Highway 155 and Vine to Shaw; west on Shaw to Peach; north on Peach to St. Louis Southwestern Railroad; northeast along the Railroad to Glenwood; northwest on Glenwood to Erwin; east on Erwin to Ross; north on Ross to Claude; east on Claude to Grand; north on Grand to Oakwood; west on Oakwood to Moore; north on Moore to Selman; east on Selman to Grand; north on Grand to Gentry; east on Gentry and Berta to the St. Louis Southwestern Railroad, the place of beginning.

MOORE MIDDLE SCHOOL - ATTENDANCE AREA

Begin at the intersection of an imaginary line extension of Berta and the District line on the east; south and east along District line to Loop 323; south along Loop 323 to Fifth Street; east on Fifth to Old Omen Road; southeast on Old Omen Road to Lamont; east on Lamont to Gish; south on Gish to Tracer; west on Tracer to Old Omen Road; southeast on Old Omen Road to McDonald Road; east on McDonald to an imaginary line east of Wakefield Drive; south on this imaginary line to another imaginary line just south of Belle Mere; west on this imaginary line to Old Omen Road; northwest on Old Omen Road to McDonald; west on McDonald to Patriot; from this point, due south to an imaginary extension of Plume Drive; west on this imaginary line to Old Troup Hwy; northwest and north on Old Troup Hwy and New Troup Hwy to Dulse; west on Dulse to Pollard; north on Pollard to Troup Hwy; east on Troup Hwy to Wylie; north on Wylie to the Railroad; southeast along the Railroad to Beckham; north on Beckham to the St. Louis SW Railroad; northeast along Railroad to an imaginary line extension of Berta; east on this imaginary line to the District line.

Special Area

All middle school students residing on Texas College Road or on any road that deadends off Texas College Road north of Loop 323 to District line will attend Moore Middle School.

STEWART MIDDLE SCHOOL - ATTENDANCE AREA

Begin at intersection of County Road 364 and Loop 323; from this point, follow an imaginary line northeast to Madison; east on Madison to Hwy 155; northeast on Hwy 155 and Vine Street to Shaw; west on Shaw to Peach; north on Peach to St. Louis Southwestern Railroad; northeast along the Railroad to Glenwood; northwest on Glenwood to Erwin; west on Erwin and Hwy 64 to an imaginary line 100 feet west of Trinity Drive; north along this imaginary line to a point just south of Hwy 110; northwest along this imaginary line just south of Hwy 110 to the District line; follow the west District line south along the Neches River and Lake Palestine to the south District line; east along the south District line to Hwy 155; northeast on Hwy 155 to Loop 323; west on Loop 323 to County Road 364, the place of beginning.

Exception

All middle school students residing on the following described portions of Lake Placid Road, County Roads 1130, 1131, and 1141, or on any road that deadends off the described portions of these roads, are to attend Hubbard Middle School: Begin at the intersection of Lake Placid Road and Hwy 155; southwest on Lake Placid Road to its intersection with County Road 1131; north on County Road 1131 to its intersection with County Road 1130; east on County Road 1130 to its intersection with County Road 1141; south on County Road 1141 to its intersection with Lake Placid Road.

SENIOR HIGH SCHOOLS - ATTENDANCE AREAS

The dividing line between John Tyler and Robert E. Lee High Schools begins at the intersection of an extension of Holly Street and the east District line; west on Holly, Lake, and Shaw to Glenwood; north on Glenwood and Herndon to Front; east on Front to Palace; north on Palace to Elm; east on Elm to Bonner; north on Bonner to Oakwood; west on Oakwood and Garden Valley to Glenwood; south on Glenwood to the St. Louis Southwestern Railroad; southwest and west along the Railroad to Loop 323; south on Loop 323 to County Road 364; west on County Road 364 to Greenbriar Road; south on Greenbriar Road to the Lone Star Gas Pipeline; west on Lone Star Gas Pipeline to the west District line.
