

# AUSTIN ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at intersection of Martin Luther King and Confederate; south on Confederate to Cochran; east on Cochran to Moore; south on Moore to Gentry; west on Gentry to Glenwood; south on Glenwood to Garden Valley Road; east on Garden Valley to Oakwood; southeast and east on Oakwood to Palace; south on Palace to Erwin; east on Erwin to Missouri Pacific Railroad; north on MP Railroad to its intersection with St. Louis SW Railroad; east on St. Louis SW Railroad to Hwy 271; north on Hwy 271 to Gentry; west on Gentry to Fannin; north on Fannin to Hillsboro; west on Hillsboro to Broadway; north on Broadway to Harmony; west on Harmony to Bois D'arc; south on Bois D'arc to Gentry; west on Gentry to Border; north on Border to Martin Luther King; west on Martin Luther King to Confederate, the place of beginning.

#### BELL ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at intersection of an imaginary line of Travis Street and St. Louis Southwestern Railroad; south along Railroad to Fifth; west on Fifth to Broadway; south on Broadway to Troup Hwy; east and southeast on Troup Hwy to Old Troup Hwy; southeast on Old Troup Hwy to Golden Road; north on Golden Road to New Henderson Hwy; east on New Henderson Hwy to Loop 323; north on Loop 323 to intersection of Old Henderson Hwy; west from this point to Arnold; west on Arnold and Travis to the St. Louis Southwestern Railroad, the place of beginning.

#### Special Area

All elementary pupils residing on Texas College Road or on any road that deadends off Texas College Road north of Loop 323 to the District line will be assigned to Bell Elementary School.

#### BIRDWELL ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at intersection of West Second and Broadway; south on Broadway to imaginary line extension of Sherry Lane; west on imaginary line and Sherry Lane to Pecandale; west on Pecandale to Silverwood; north on Silverwood to Woodlark; west on Woodlark to Post Oak Road; north on Post Oak Road to Jacksonville Road; southwest on Jacksonville Road to the railroad; north along railroad to Ben Street; west on Ben Street to Highway 155; northeast on Hwy 155 and Vine Street to West Second; east on West Second to Broadway, the place of beginning. Special Area

Begin at intersection of Nutbush and Fenton; south on Fenton to Harmony; east on Harmony to Englewood; south on Englewood to Gentry; east on Gentry to Moore; north on Moore to Cochran; west on Cochran to Confederate; north on Confederate to Nutbush; west on Nutbush to Fenton, the place of beginning.

## BONNER ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at the intersection of the District line on the east with an imaginary line extension of Berta Street; west on this imaginary line extension of Berta to the St. Louis Southwestern Railroad; southwest along St. Louis SW Railroad to its intersection with Missouri Pacific Railroad; south along MP Railroad to an imaginary line extension of Travis Street; east on this imaginary line and Travis Street to Palmer; south on Palmer to Arnold; east on Arnold and an imaginary line extension of Arnold to the District line; follow District line north to its intersection with an imaginary line extension of Berta, the place of beginning.

#### CLARKSTON ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at intersection of Fifth Street and Golden Road; east on Fifth Street to Old Omen Road; southeast on Old Omen Road to Lamont; east on Lamont to Gish; south on Gish to Tracer; west on Tracer to Old Omen Road; southeast on Old Omen Road to McDonald Road; east on McDonald to an imaginary line east of Wakefield; south on this imaginary line to another imaginary line just east of Belle Mere; west on this imaginary line to Old Omen Road; northwest on Old Omen Road to McDonald; west on McDonald to Patriot; from this point, follow an imaginary line due south to G. E. Road (Spur 12); west on Spur 12 to Troup Hwy; northwest on Troup Hwy to its intersection with Old Troup Hwy north of Loop 323; southeast on Old Troup Hwy to Golden Road; north on Golden Road to Fifth Street, the place of beginning. Special Area No. 1

Begin at the intersection of 24th and Gaston; south on Gaston to Martin Luther King; west on Martin Luther King to Fenton; south on Fenton to Nutbush; east on Nutbush to Confederate; north on Confederate to Martin Luther King; east on Martin Luther King to Moore; north on Moore to the Railroad; northwest on Railroad to a point where 24th would cross Railroad; east from this point on an imaginary line extension of 24th to Gaston, the place of beginning.

Special Area No. 2

Elementary pupils residing on State Hwy 14 or on any road that deadends off Highway 14 north of County Road 328 to District line are assigned to Clarkston Elementary School.

#### DIXIE ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at District line on the west at the intersection of Lone Star Gas Pipeline; east along Lone Star Gas Pipeline to Greenbriar Road; north on Greenbriar Road to County Road 364; east on County Road 364 to Loop 323; north on Loop 323 to St. Louis SW Railroad; west on Railroad to an imaginary line 100 feet west of Morgan Avenue; north along this imaginary line to Hwy 64; west on Hwy 64 to an imaginary line just west of Trinity Street; north on this imaginary line to its intersection with another imaginary line just south of Hwy 110; north and west along this line to the District line; west and south on District line to Lone Star Gas Pipeline, the place of beginning.

## DOUGLAS ELEMENTARY SCHOOL - ATTENDANCE AREA

From District line on the east along Hwy 271 to Duncan; west on Duncan and Mims to Moore; south on Moore to Martin Luther King; east on Martin Luther King to Border; south on Border to Gentry; east on Gentry to Bosi D'arc; north on Bois D'arc to Harmony; east on Harmony to Broadway; south on Broadway to Hillsboro; east on Hillsboro to Fannin; south on Fannin to Gentry; east on Gentry to Hwy 271; south on Hwy 271 to the St. Louis SW Railroad; northeast along Railroad to an imaginary line extension of Berta; east along this imaginary line to the District line; follow the District line north and east to Hwy 271, the place of beginning.

## GARY ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at intersection of West Erwin and St. Louis Southwestern Railroad; south along St. Louis SW Railroad to Front; east on Front to Palace; south on Palace to Vine; south on Vine to Second; east on Second to Broadway; south on Broadway to Fifth; east on Fifth to Missouri Pacific Railroad; north along MP Railroad to Erwin; west on Erwin to St. Louis SW Railroad, the place of beginning. Special Area

Begin at intersection of Loop 323 and Robertson Road; east on Robertson to St. Louis Southwestern Railroad; southeast along St. Louis SW Railroad to Hwy 155; southwest along Hwy 155 to Madison; west on Madison and an imaginary line to Loop 323 at intersection with Spur 364; north on Loop 323 to Robertson Road, the place of beginning.

## GRIFFIN ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at the intersection of Loop 323 and the Missouri Pacific Railroad; northeast along Loop 323 to a point just east of Texas College Road; north along an imaginary line to the District line; east along the District line to Hwy 271; south along Hwy 271 to Duncan; west on Duncan and Mims to Moore; north on Moore to the Missouri Pacific Railroad; northwest along the MP Railroad to Loop 323, the place of beginning.

## Exception

All elementary pupils residing on State Hwy 14 or on any road that deadends off Hwy 14 north of County Road 328 to the District line will be assigned to the Clarkston Elementary School.

# JACK ELEMENTARY SCHOOL – ATTENDANCE AREA December 4, 2006

Begin at the corner of Grande Blvd. and S. Broadway. South on S. Broadway to Cambridge Rd. East on Cambridge Rd. to Cambridge Bend. South on a subdivision line between Cambridge Bend Estates subdivision and Wilken Plaza subdivision to the Wilder subdivision. East on a subdivision line between the Cambridge Bend Estates and Wilder subdivision. North on a subdivision line between Cambridge Bend Estates and Wilder Subdivison and then east on the subdivision line to the boundary between TISD and Whitehouse ISD. Following the eastern boundary between TISD and WISD to the southern border between TISD and WISD westward to FM 2813. FM 2813 west to FM 2493 (Old Jacksonville Rd.) north to Loop 49. Loop 49 west to Hwy 155. Hwy 155 south to FM 1261 (Big Eddy Rd.) FM 1261 to FM 2661. North on 2661 to the north side of Silverleaf Resorts and the south side of Lot/Tract TR11P then west to the western boundary of TISD on the shoreline of Lake Palestine. North along the shore of Lake Palestine to CR 1140. CR 1140 east to TP&L transmission line to intersection with Lone Star Gas pipeline. Southeast along transmission line/pipe line to Grande Blvd. East along Grande Blvd. to the place of beginning.
