School Description and Mission Statement (School Year 2008-09)

At Los Alamitos Elementary (LAE), our vision is to have all students learn in a safe, supportive, challenging environment that empowers them to become lifelong learners, as well as responsible, productive citizens with positive character traits. Staff, parents, and members of the community work together in a committed partnership to ensure that the academic, social, emotional, and physical needs of all children are met with success. Our mission is to achieve SUCCESS: Skillfully instruct all students to mastery through a balanced curriculum including the arts and technology Use appropriate standards-based assessments Carefully identify students at-risk Collaborate and communicate often Ensure all students have the opportunity to have their social and emotional needs met Support healthy habits Seek to continuously learn, grow, and improve. Our primary goals are to ensure that every student: 1) masters the district and state content standards in all subject areas; 2) engages in algebraic thinking, and the balance of computation and problem-solving skills in mathematics; 3) masters basic reading skills with an emphasis on reading and writing across all content areas; 4) receives enrichment and early interventions to meet social/emotional and academic needs; and 5) every staff member participates in professional growth activities that promote continuous improvement. We also participate in the Music Neural Intelligence Development (MIND) Institute program, Cognitively Guided Instruction (CGI) in mathematics, and the Art Masters Program.

## Opportunities for Parental Involvement (School Year 2008-09)

Los Alamitos Elementary School has a variety of ways for parents to become involved in school activities and events. The first is through an active Parent-Teacher Association (PTA). Monthly meetings focus on opportunities for parents to become involved at school and acquainted with one another. PTA seeks to raise funds and to provide activities that support the learning that takes place in school. The Los Alamitos Elementary School PTA provides funding for school assemblies, instructional materials and support, as well as educational opportunities for parents. The Friends of Los Alamitos Elementary (FLAE) Booster Club was developed to raise funds to support school programs. Funds from FLAE have brought the MIND Institute to our school and ensured that technology continues to be upgraded. The booster club also assists with professional development needs and instructional materials. To raise these needed funds, parents coordinate two major fundraisers: an annual fit-a-thon and an evening dinner and auction known as our Starry Night Dinner and Auction. FLAE meetings are held monthly with all parents welcome to attend. The LAE School Site Council (SSC) provides community involvement in developing, monitoring and evaluating the School Improvement Plan. Membership is open to five school/community and five school staff members. Parents are encouraged to attend the SSC meetings to become familiar with curriculum, instructional practices, and assessment measures. The SSC meets four times per year. The parent volunteer program at Los Alamitos Elementary School is called V.I.T.A.L. (Volunteers in Teaching and Learning). The V.I.T.A.L group includes helpers in classrooms, tutors, clerical assistants, and workers preparing instructional materials. Volunteers are also used in the media center, computer lab, music program, office and health office. A parent volunteer training program at the beginning of the year gives parents the opportunity to learn how to work with children effectively in the classroom, and use our machines in the work room. The Los Alamitos Unified School District has always emphasized the importance of a clean, safe environment for learning. The environment of each campus is a matter of pride for students, staff and parents. Several schools have planted individual gardens, organized workrooms, and planned workdays for students and parents to enhance the facility. To insure that our facilities are in good repair condition, custodians at each site perform monthly safety inspections and the District maintenance crew places safety as the number one priority. Los Alamitos Elementary School was built in 1950. Overall the school is in good condition for a facility of that age. It is clean and well maintained but the building systems/infrastructure are old and in need of major repair or replacement. Doors will be replaced during modernization. Voters within the District boundaries have approved a local bond which will allow the District to access State bond funds to modernize schools. Los Alamitos Elementary School is next in line for modernization. The modernization plans for this school are in plan check with the state. Construction is to begin in June of 2010. Los Alamitos Unified School District sets a high priority upon ensuring that high quality, standards-based textbooks and materials are available for every student to support instructional programs in the schools. Prior to adoption, the Los Alamitos Unified School District conducts a thorough review of its curriculum to ensure that it is aligned with the State Frameworks and high academic standards. Under California law, the State Board of Education reviews K-8 textbooks and other instructional materials and then adopts those meeting specific quality standards. In the Los Alamitos Unified School District, textbooks considered for adoption are carefully reviewed by a committee of teachers and administrators. The most promising programs are piloted using established criteria and guidelines. The recommended books are then approved by the Los Alamitos Unified School District Board of Education. To receive State instructional funds, the Los Alamitos Unified School District ensures that it has fully complied with the requirements of Education Code Section 60119. The District has also conducted an annual public hearing ensuring the sufficiency of instructional materials. Each school maintains a library/media center which is supported by District and State supplemental funding.

## IX. Student Performance

## Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA for grades three through eight and science in grades five and eight and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. ## XI. Instructional Planning and Scheduling

## Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

All professional development is designed to improve student achievement. School sites analyze their students' assessment data, determine needs, and select staff development to address these needs. Staff members also receive training on newly adopted textbooks, technology, and State frameworks. This year's staff development priority goals include maintaining a culture that promotes professional growth and continuous improvement. Districtwide staff development days have been used for the following:

1. Working with all staff on making progress as a Professional Learning Community.
2. Supporting teacher collaboration for the purpose of analyzing test results, revising curriculum, planning lessons, responding to instruction, and revising common benchmark assessments.
3. Training teachers on the use of Data Director as a tool for analyzing common assessments in order to provide appropriate interactions.
4. Training teachers to be coaches for other teachers when implementing a new program.
5. Training teachers on Cognitively Guided Instruction to better prepare students for algebraic thinking and problem solving.
6. Providing staff development in the writing process, on-demand writing, and instructional strategies to improve student writing.
7. Training teachers on differentiation of instruction with an emphasis on strategies for GATE and English learners.
8. Providing professional development and support for teachers and parents in dealing with students with special needs.
9. Providing regularly scheduled job-alike articulation meetings.
10. Training staff on selecting appropriate education placements and on using correct procedures in developing Individualized Education Programs (IEPs).
11. Providing information to parents regarding support groups and conferences that relate to the needs of their children.
12. Providing training on the use of technology.
13. Training teachers on the implementation of intervention materials.

In addition to districtwide staff development, each site sets staff development goals to be met at grade/department-level meetings, staff meetings, and professional groups.

As part of the professional evaluation process, each staff member sets personal professional growth goals in the fall. Goals are met through attendance at college courses, workshops and conferences, professional reading, visitations to other schools, and collaborative work with other educators. Staff members demonstrate a sincere desire and commitment to ongoing improvement.

In addition, LAUSD is part of the Orange County Beginning Teacher \& Support Assessment (BTSA) consortium, which offers training to highly qualified, trained teachers, who provide guidance for new teachers.

## XII. National Assessment of Educational Progress

## National Assessment of Educational Progress

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities and English language learners is reported based on three levels (identified, excluded, and assessed). Detailed information regarding the NAEP results for each grade, performance level, and participation rate can be found on the National Assessment of Educational Progress Web page (Outside Source).

Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess Englishlanguage arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
