

Updated 4/12/06

During its January 29, 2006, February 21, 2006 and April 4, 2006 meetings, the Guilford County Board of Education approved several attendance zone changes that will affect elementary, middle and high schools located in the northwest, northern, northeastern and eastern parts of the county.

Rising fifth, eighth, tenth, eleventh and twelfth graders will be allowed to stay at their previously assigned school without transportation, as outlined in Board Policy JBCC.

Southwest and Colfax Elementary

The Board approved a shift to Colfax Elementary in 2007-08 of the northern portion of the Southwest Elementary attendance zone. This area includes:

- Sandy Ridge Road area west of Squire Davis Road
- The north side of Sandy Ridge Road between Squire Davis Road and Clinard Farms Road
- The area north of Clinard Farms Road between Sandy Ridge Road and NC 68
- The area north of Piedmont Parkway between NC 68 and the creek (north/south) between Tarrant Road and Hickory Grove Road
- The area west of the creek between Tarrant Road and Hickory Grove Road to I-40
- And the area south of I-40/Bus 40 between west of Roanne Way and the Forsyth County line

The area is marked as E226 on the Colfax/Southwest Elementary Map.

Oak Ridge Elementary

The Board approved changing the Oak Ridge Elementary attendance zone; effective with the 2007 school year.

- Oak Ridge gains an area currently served by Stokesdale Elementary, which includes Linville Road north of Haw River; the area is bounded on the east by W. Harrell Road and on the north by Haw River
- Oak Ridge Elementary School students living in the Edgefield Road area (south of and including Edgefield Road) and the Pleasant Ridge Road area will shift from Oak Ridge Elementary to Colfax Elementary

New Guilford Elementary School

The Board approved attendance lines for the new Guilford Elementary, which replaces Guilford Primary and causes attendance zone changes for Jefferson Elementary; effective 2007 once the new school opens.

- Guilford Elementary would gain the Jefferson Elementary area west of and including the west side of Fleming Road and New Garden Road between Friendly and Ballinger Road north of Friendly Avenue
- Guilford Elementary would lose the area south of W. Market Street and east of Meadowood Street. Streets connecting with the east side of Meadowood would remain with Guilford Elementary
- Jefferson Elementary would gain the Guilford Primary area south of W. Market Street and east of Meadowood excluding streets off of Meadowood south of the railroad
- Jefferson would lose the area west of Fleming Road and west of New Garden between West Friendly Avenue and Ballinger Road

New Northwest Area Elementary School

The Board approved an attendance zone for the new northwest area elementary school; effective 2007 once the new school opens.

- The Colfax Elementary area east of Old Oak Ridge Road, including the east side of Old Oak Ridge Road
- The Oak Ridge Elementary area on the north side of Pleasant Ridge Road, between Alcorn and White Blossom Drive, and the Laughlin/Summerfield Elementary area west of Lewiston Road

New Reedy Fork Area Elementary School

The attendance zone for the new Reedy Fork area elementary school will serve students currently attending Monticello-Brown Summit, Brightwood and Madison Elementary Schools; effective in 2007 once the new school opens.

- Assign the area from Monticello-Brown Summit Elementary north of Reedy Fork Creek and west of McLeansville Road
- Assign the Brightwood Elementary Summit Avenue area north of Candlenut Road and Lees Chapel Road north of Bush Road
- From the Madison Elementary area, Reedy Fork would serve students residing in the area north of Hicone Road and the north side of Hicone Road, as well as those residing in the area west of McKnight Mill Road
- Assign the Rankin area east of US 29 to Madison, Northeast Middle and Northeast High

New Northern Elementary School

The Board approved an attendance zone for the new Northern Elementary School that will mostly follow the middle and high school lines with the following exceptions. This will be effective in 2007 with the opening of the new school.

- Follow the middle/high school attendance line east of Lake Brandt Road between Haw River and NC 150 West
- Both sides of Lake Brandt Road north of Haw River
- Both sides of Lake Brandt Road south of NC 150 West

New Northern High and Northern Middle Schools

The Board approved an attendance zone for the new Northern Middle and High Schools; attendance lines are the same for both schools. The attendance zone includes most of the Laughlin/Summerfield attendance zone plus the Monticello-Brown Summit area mostly east of Yanceyville Road, plus the a western portion of the Brightwood zone. The rising sixth grade students in this forenamed area residing in the 2005-06 attendance zones of Northeast Middle and Northwest Middle (not Kernodle) are scheduled to attend Northern Middle in January of 2007. During the fall of 2007, rising ninth and tenth grade students will attend the new Northern High School; rising eleventh and twelfth grade students, who reside in the new attendance zone, will remain at their current high schools.

- The northern boundary is the Rockingham/Guilford line.
- The western line is (1) a line west of and parallel to Lake Brandt Road and north of Haw River, (2) Haw River from west of Lake Brandt Road to just east of Haw View Court (west of Deboe Road), (3) line south from Haw River to Oak Ridge Road (NC 150 West) that is west of Twin Leaf Trail and east of Auburnwood Drive and Phillips Court, (4) west of Katherine Louise Dr. and south of Oak Ridge Road, (5) along a creek that flows under Brookbank Road at a point east of the I73 corridor and west of Banning Road to Reedy Fork Creek (north of Bunch Road), (6) hence to the intersection of Stanley Huff Road and Bunch Road, (7) hence along the eastern side of Stanley Huff Road to Moore's Creek, (8) hence a line east of Stanley Huff Road to the intersection of Carlson Dairy Road and Pleasant Ridge Road, (9) hence along a line between Carlson Dairy Road and Lewiston Road to Lake Higgins.

- The southern line follows (1) a line through Lake Higgins from the Carlson Dairy Road bridge to a point west of Laurinda Drive, (2) hence along a line south of Laurinda Drive to just south of the intersection of Laurinda Drive and Battleground Avenue, (3) hence along the centerline of Battleground in a southerly direction to the creek feeding into Lake Brandt that is just south of Willow Grove Court and north of White Horse Drive, (4) hence through Lake Brandt to its dam just west of Lake Brandt Road, (5) hence along the center of Reedy Fork Creek and into Lake Townsend from Lake Brandt Road on the west to Church Street (northern bridge) on the east, (6) hence through Lake Townsend to the southern Church Street bridge across Lake Townsend at the southwestern basin of the lake, (7) hence along the centerline of Church Street to the intersection of Church Street and the proposed Urban Loop (Painter Boulevard's northern section), (8) hence along the proposed Urban Loop corridor to the Duke Power transmission line that is east of Holly Ridge Road and east of Shady Pine Drive, (9) hence north, along a line east of Holly Ridge Road, to a point even with Gilchrist Road, (10) hence east to Yanceyville Road along the southern margin of Gilchrist Road (south of Sunstar Court and north of Zelkova Court), (11) hence north along the centerline of Yanceyville Road to the intersection of Hillcroft Road and Yanceyville Road.
- The eastern line follows (1) a line east from the Hillcroft Road and Yanceyville Road intersection along the northern margin to a creek that flows north to Lake Townsend that is west of Terrapin Court, (2) hence north along the creek to Lake Townsend, (3) hence through Lake Townsend to the northern-most bridge of Doggett Road over Lake Townsend, (4) hence north through the northern basin of Lake Townsend (east of Townsend Forest Court), (5) hence north along the western creek flowing into northern-most point of Lake Townsend, (6) hence to 5448 Yanceyville Road, (7) hence north along the center line of Yanceyville Road to north of 5496 Yanceyville Road, (8) hence east along the southern boundary of the Columbia Village subdivision and north along the eastern boundary of Columbia Village to the intersection of NC 150 East and Spearman Road, (9) hence east along the centerline of NC 150 East from Spearman Road to Fairgrove Church Road, and hence along the centerline of Fairgrove Church Road north from NC 150 East to the Rockingham County line.
