

JONES ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at the intersection of an imaginary line 100' west of Morgan Street and Hwy 64; south along this imaginary line to St. Louis Southwestern Railroad; east on Railroad to Loop 323; south on Loop 323 to Robertson Road; east on Robertson Road to an imaginary line extension from Turner Avenue; north along this imaginary line and Turner Avenue to St. Louis Southwestern Railroad; east along the Railroad to Lyons; north on Lyons to Front; east on Front to St. Louis Southwestern Railroad; north on Railroad to Erwin; west on Erwin and Hwy 64 to imaginary line 100' west of Morgan Street, the place of beginning.

ORR ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at intersection of the District line on the north and an imaginary line west of Hwy 110; follow this imaginary line along Hwy 110 to its intersection of another imaginary line 100 feet west of Trinity Street; follow this imaginary line west of Trinity Street south to Hwy 64; southeast on Hwy 64 to Loop 323; north on Loop 323 to Van Hwy; east on Van Hwy to Gentry; southeast on Gentry to Martin Luther King; northeast on Martin Luther King to Cecil; north on Cecil to 24th Street; east on 24th Street to Missouri Pacific Railroad; northwest on MP Railroad to Loop 323; northeast on Loop 323 to an imaginary line just west of Texas College Road; north on this imaginary line to the District line; west along District line to place of beginning.

OWENS ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at District line on the west with the intersection of Lone Star Gas Pipeline; east along pipeline to intersection with the T P & L Transmission line; southwest along transmission line to the intersection with an imaginary line extending west from Cumberland Road; east on imaginary line and Cumberland Road to Cherokee Trail; south on Cherokee Trail to the District line (students living on both sides of Cumberland Road and Cherokee Trail attend Rice. Students living on any road on the east side of Highway 69 which dead ends from Cumberland Road or Cherokee Trail will attend Rice); east, south, west along District boundary line to Lake Palestine; north along Lake Palestine to Lone Star Gas Pipeline, the place of beginning.

OWENS ELEMENTARY SCHOOL – ATTENDANCE AREA  
December 4, 2006

At the shoreline of Lake Palestine on the north side of Silverleaf Resorts and the south side of Lot/Tract TR11P to FM 2661. South on FM 2661 to FM 1261 then east on FM 1261 (Big Eddy Rd.) to Hwy 155. Northeast on Hwy 155 to Loop 49. East on Loop 49 to FM 2493 (Old Jacksonville Rd.) South on FM 2493 to FM 2813. East on FM 2813 to the eastern boundary between TISD and Whitehouse ISD. South along the boundary between TISD and WISD. West along the district boundary line between TISD and Bullard ISD to the shore of Lake Palestine. North along the shore of Lake Palestine to the place of beginning.

PEETE ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at intersection of Palace and Front; west on Front to Lyons; south on Lyons to St. Louis Southwestern Railroad; west on Railroad to Turner Avenue; south on Turner Avenue and an imaginary line to Robertson Road; east on Robertson Road to Railroad; southeast along Railroad to Hwy 155; north on Hwy 155 and Vine Street to Palace; northwest on Palace to Front, the place of beginning.

RAMEY ELEMENTARY SCHOOL - ATTENDANCE AREA

Begin at the intersection of Loop 323 and Van Hwy; south on Loop 323 to Erwin; east on Erwin to Palace; north on Palace to Oakwood; west on Oakwood and Garden Valley to Glenwood; north on Glenwood to Gentry; east on Gentry to Englewood; north on Englewood to Harmony; west on Harmony to Fenton; north on Fenton to Martin Luther King; east on Martin Luther King to Gaston; north on Gaston to 24th Street; west on 24th Street to Cecil; south on Cecil and Wolford to Martin Luther King; southwest on Martin Luther King to Gentry; northwest on Gentry to Van Hwy; west on Van Hwy to Loop 323, the place of beginning.

RICE ELEMENTARY SCHOOL - ATTENDANCE AREA (NEAR OWENS ELEMENTARY)

Begin at the intersection of the Greenbriar Road and T P & L transmission line; north on Greenbriar Road to County Road 364; east along County Road 364 to Loop 323 and an imaginary line to Madison; east on Madison to Hwy 155; southwest on Hwy 155 to Loop 323; east on Loop 323 to Jacksonville Road; northeast on Jacksonville Road to Post Oak Road; south on Post Oak Road to Woodlark; east on Woodlark to Silverwood; south on Silverwood to Pecandale; east on Pecandale, Sherry Lane, and an imaginary line to Broadway; south on Broadway to Loop 323; east on Loop 323 to Copeland Road; south on Copeland Road and south and west on District line to intersection of imaginary line from Cherokee Trail; north on Cherokee Trail to intersection of Cumberland Road (students living on both sides of Cumberland Road and Cherokee Trail attend Rice. Students living on any road on the east side of Highway 69 which dead ends into Cumberland Road or Cherokee Trail will attend Rice); west on Cumberland Road and imaginary line to intersection with T P & L transmission line; northwest along T P & L transmission line to intersection with Lone Star Gas pipeline; west along pipeline to intersection with Greenbriar Road, the beginning place.

Begin at District line on the west at the intersection of Lone Star Gas Pipeline; east along the Pipeline to Greenbriar Road; north on Greenbriar Road to County Road 364; east along County Road 364 and an imaginary line to Madison; east on Madison to Hwy 155; southwest on Hwy 155 to Loop 323; east on Loop 323 to Jacksonville Road; northeast on Jacksonville Road to Post Oak Road; south on Post Oak to Woodlark; east on Woodlark to Silverwood; south on Silverwood to Pecandale; east on Pecandale, Sherry Lane, and an imaginary line to Broadway; south on Broadway to Loop 323; east on Loop 323 to Copeland Road; south on Copeland Road to District line; east, south, and west on District line to Lake Palestine; north along Lake Palestine to Lone Star Gas Pipeline, the place of beginning.



## RICE ELEMENTARY SCHOOL – ATTENDANCE AREA

Begin at intersection of Greenbriar Road and TP&L transmission line; north on Greenbriar Road to Spur 364; east along Spur 364 to Loop 323 and an imaginary line to Madison; east on Madison to State Hwy 155 S; southwest on Hwy 155 to Loop 323; east on Loop 323 to Old Jacksonville Hwy (FM 2493); northeast on FM 2493 to Post Oak Road; south on Post Oak Road to Woodlark; east on Woodlark to Silverwood; south on Silverwood to Pecandale; east on Pecandale, Sherry Lane, and an imaginary line to Broadway; south on Broadway to Loop 323; east on Loop 323 to Copeland Road; south on Copeland Road to the boundary of TISD and Whitehouse ISD following south to intersection of Cambridge Bend Estates and Wilder subdivisions. West along subdivision line between Cambridge Bend Estates and Wilder subdivisions. South along subdivision line between Cambridge Bend Estates and Wilder subdivisions. West along subdivision line between Cambridge Bend Estates and Wilder subdivisions. North along subdivision lines between Cambridge Bend Estates and Wilkens Plaza subdivisions to Cambridge Bend and Cambridge Rd. West on Cambridge Rd. to S. Broadway. North on S. Broadway to Grande Blvd. West on Grande Blvd. to Hwy 155. Northwest along TP&L transmission line and pipeline to Greenbriar Rd the place of beginning.
