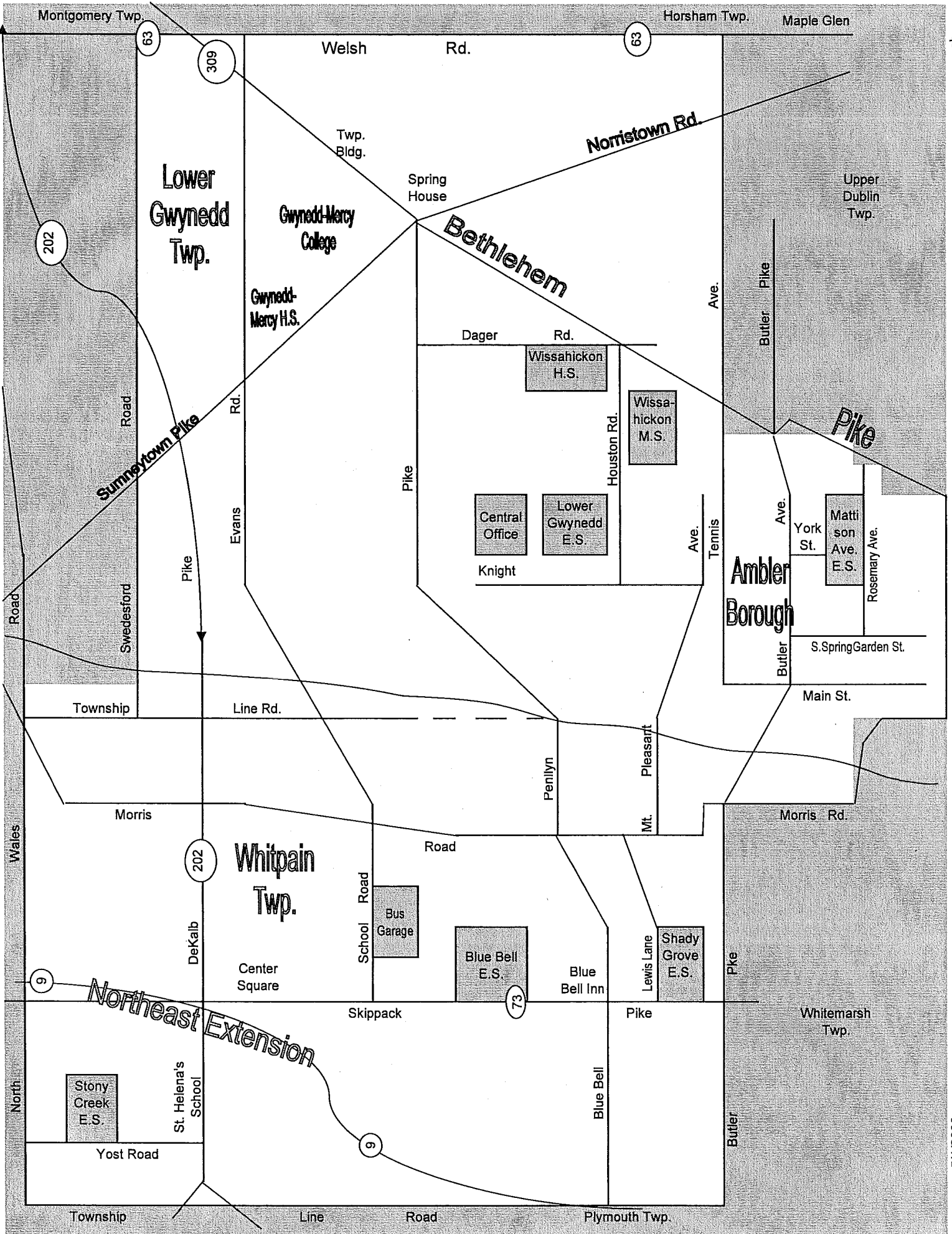


Wissahickon School District



Wissahickon School District Boundaries of School Sending Areas

Boundaries on roads will be the center line of said road unless otherwise state.

BLUE BELL

The sending area for Blue Bell School will be bounded by a line starting at the corner of North Wales Road and Morris Road proceeding east on Morris Road to Route 202 to Yost Road. From the intersection of Route 202 and Yost Road an imaginary line will be drawn in a southeasterly direction to Township Line Road just east of, but not including, the Townline Development. Then east on Township Line Road to Penllyn Blue Bell Pike, North on Penllyn Blue Bell Pike to Old Penllyn Pike, northeast (including both sides of Old Penllyn Pike) to the railroad track, northwest along the railroad to Gwynedd Avenue. From there an imaginary line will be drawn in a westerly direction to the dead end of Township Line Road (closest to Plymouth Road), west along Township Line Road to the Whitpain Township border then south to Morris Road.

LOWER GWYNEDD

The sending area for Lower Gwynedd School will be bounded by a line starting at the intersection of Welsh Road and Swedesford Road proceeding south on Swedesford road to Route 202, south on Route 202 to Swedesford Road, south on Swedesford Road to Sumneytown Pike, east on Sumneytown Pike to Penllyn Pike, south on Penllyn Pike to Old Penllyn Pike, south on Old Penllyn Pike to the railroad, east along the railroad to the Tennis Avenue underpass, north along Tennis Avenue to Ridge Avenue (including houses on both sides of Tennis Ave.), along a line to the end of Edgewood Ave., north along Edgewood Ave. (including both sides of Edgewood Ave.) to Bethlehem Pike, northwest along Bethlehem Pike to Tennis Avenue, north on Tennis Avenue to Welsh Road, west on Welsh Road to Swedesford Road.

MATTISON AVENUE

The sending area for Mattison Avenue School will be bounded by a line starting at the corner of Bethlehem Pike and Edgewood Drive proceeding south on Edgewood Drive, (excluding houses on both sides of Edgewood), to the end of Edgewood, then along an imaginary line to the corner of Tennis Avenue and Ridge Avenue, south along Tennis Avenue (excluding houses on both sides of Tennis Avenue) to the railroad tracks, east along the railroad tracks to the Ambler Borough line, then following the Ambler Borough Line back to Bethlehem Pike and Edgewood Drive.

SHADY GROVE

The sending area for Shady Grove School will be bounded by a line starting at Township Line Road and Butler Pike in the southeast corner of Whitpain Township going west on Township Line Road to Penllyn Blue Bell Pike, north on Penllyn Blue Bell Pike to Old Penllyn Pike, northeast on Old Penllyn Pike (not including any properties currently fronting on either side of Old Penllyn Pike) to the railroad track, then northwest along the railroad to Gwynedd Avenue. From there an imaginary line will be drawn in a westerly direction to the dead end of Township Line Road (closest to Plymouth Road), west along Township Line Road to Swedesford Road, then north on Swedesford Road to Sumneytown Pike, east on Sumneytown Pike to Penllyn Pike, south on Penllyn Pike to Old Penllyn Pike, south on Old Penllyn Pike to the railroad, east along the Ambler-Upper Dublin border, returning west along the Whitpain border to Butler Pike and continuing south to Township Line Road.

STONY CREEK

The sending area for Stony Creek School will be bounded by a line starting at North Wales Road and Township Line Road in the southwestern corner of Whitpain Township, going north on North Wales Road to Morris Road, east on Morris Road to Route 202, south on Route 202 to Yost Road. From the intersection of Route 202 and Yost Road an imaginary line will be drawn in a southeasterly direction to Township Line Road just east of, and including, the Townline Development. From there proceed west on Township Line Road to North Wales Road.
